(FEDERAL ENERGY REGULATORY COMMISSION)

(CLEAN AIR ACT)

**WHAT KIND OF DATA?**

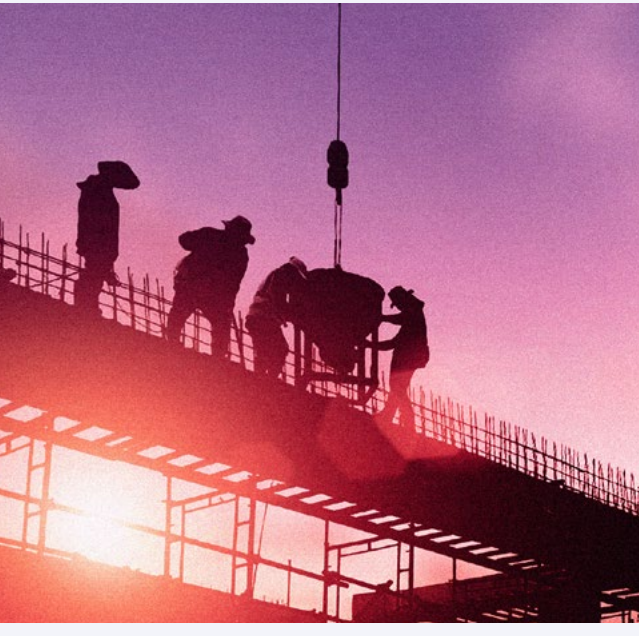
Emissions records

**WHAT'S THE REQUIREMENT?**

5 YEARS<sup>2</sup>

**WHAT DOES IT APPLY TO?**

- Major sources of air pollution
- Sources subject to NESHAP
- Manufacturers of vehicles and engines



## OSHA

(OCCUPATIONAL SAFETY AND HEALTH ADMINISTRATION)

**WHAT KIND OF DATA?**

Injury and illness records

**WHAT'S THE REQUIREMENT?**

5 YEARS<sup>3</sup>

\$156,259

per violation

## CWA

(CLEAN WATER ACT)

**WHAT KIND OF DATA?**

Water quality and pollution control records

**WHAT'S THE REQUIREMENT?**

6 YEARS<sup>4</sup>

**WHAT DOES IT APPLY TO?**

- Facilities that discharge pollutants into US waters
- Concentrated animal feeding operations of certain size/discharge criteria
- Industrial facilities subject to Effluent Limitation Guidelines



## EPA

(ENVIRONMENTAL PROTECTION AGENCY)

**WHAT KIND OF DATA?**

Hazardous waste management records

**WHAT'S THE REQUIREMENT?**

3 YEARS<sup>5</sup>

**WHAT DOES IT APPLY TO?**

- Large quantity generators of hazardous waste
- Treatment, storage and disposal facilities
- Recycling facilities
